Fairfax Traffic Chief killed in head-on collision

Capt. Tommy F Bernal, 51, was on a motorcycle training run with fellow officers when another motorcycle officer ahead of him skidded into oncoming traffic. The driver of a SUV swerved to avoid the rider and hit Bernal as he crested a hill. The driver was not charged.

Bernal is the second officer in the department's 61 years to die in the line of duty, and the first since 1977.

"The police department has certainly

lost one of its best", said a friend of Bernal's for more than 15 years.

Bernal was a 29-year veteran of the department. Since early 1999, he had headed Fairfax county traffic division, which has won numerous awards for its innovations in combating drunken driving and promoting child car-seat safety. He is survived by his wife Marlis, and three sons.

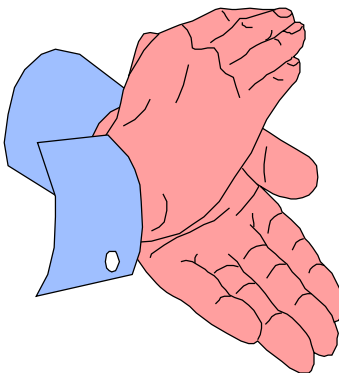

Victim Restitution Alert

The Division of Parole and Probation has diligently worked to improve the collection of court ordered restitution for victims who suffer financial losses as a result of crime. Though the Division efforts have become more successful, restitution is still being collected long after it was originally ordered. Occasionally, changes such as in residence have occurred and the Division has been unable to locate the victims to make disbursements. If
