This year's theme featured MADD "Mission In Motion", which covered the bumps and barricades before us. MADD wants to continue charging down the road towards safety and keeping families whole. Hill1's agenda for the conference was to attend the African American Coalition Meeting and see how we can help bring the message of drinking and driving to the African American communities.

The Forum addressed the differences in the Black Communities regarding the availability of alcohol products and saturation of advertisement. The second speaker of the forum discussed MADD plan to begin working on the new FAITH-BASED initiative. The forums theme verses the root of the problem in the African American Community and ties to alcoholism, was oblivious in resolution to MADD mission.

In my opinion, the meeting lacked visibility in

organization of preventive alternatives and educational programs that would assist African American Communities in saving lives and fallen victims to drunk drivers.

Youth Corner

Healing Innocent Lost Love Ones Foundation (Hill1) earmarked the first official youth awareness initiative. The effort coordinated by Jonathan Hill (former HILL1 CEO) and HILL1's Public Relations Coordinator, Rhonda Hall presented an opportunity for the organization to help bridge the awareness gap amongst the youth population by offering preventive underage drinking alternatives and education about the risk associated with teenage drinking and driving.

The event assembled at the Archbishop Carroll Catholic High School in NE, Washington, DC. Archbishop Carroll (ACHS), also Alma meter of Jonathan Hill yielded a unique experience for the former student in community outreach service. More then 200 graduating high school seniors and several faculty members were inundated about the heinous danger affiliated with teenage drinking and driving and the affects of adolescents and alcoholism.

The onset of the program featured a 6-minute video, narrated by the father of a 17 year old male whose life was succumb to operating a vehicle after the consumption of just a few ounces of alcohol. The message was further underscored with the story about the young life of Malcolm Duane Xavier Hill, and the Mission of the Hill1 Foundation. Afterwards, students volunteered to partake in demonstrations using simulated visual aids to better understand Blood Alcohol Levels (BAC) and the variances in impairment levels and the impact of operating a vehicle.

Students and faculty gained first hand experience and education by observing depictions of victims and non-victim experiences and by engaging in exercises that featured technology designed to distort loss in equilibrium. In addition, they learned about the grueling statistics surrounding drinking and driving that afflicts our youth, and received reference material and information about support groups and networking was disseminated to all students.

Near the close of the program, the youths were presented with a challenge to "Take A Pledge To Be A Responsible Driver" and to be an advocate in the campaign with the Hill1 Foundation to help prevent lost of life to senseless acts of drinking and driving.

SOMETHING TO THINK ABOUT

My husband was the designated driver as usual returning from an out of town baseball game with one of his buddies. He was pulled over, his blood alcohol tested just above the limit and he was arrested and jailed. Fair enough, but what about the ensuing expenses—thousands of dollars in fines legal fees and the hike in our insurance? My husband accepts responsibility, but shouldn't his friend offer some financial help?

The response from the editor was:


I can understand your feelings . Your husband's buddy drank with him, presumably made no attempt

To prevent him from imbibing, maybe even paid for a round or two (if he's not a cheapskate) and then acquiesced in his driving. At that point, the two of them might have decided that your husband got pulled

over, they would have share resulting expenses

So isn't the buddy implicated in your husband's bad conduct? Implicated yes, but not responsible for it. I share your husband's belief that he is accountable

> for his own misbehavior. He drove drunk, he got caught-even more discreditably because he had agreed to be the designated driver, That means he's supposed to say particularly clearheaded, not flirt with the legal limited. Thus, he not only broke the law; he also failed in his duty and thus endangered his buddy and other drivers on the road.



He and his friend— if they are still friends—might want to refine their arrangement so that they take turns being the designated driver, but once either of them takes on that role, he must live up to his obligation. They might also agree in advance to share all the costs of driving which included tickets. But in the present situation, your husband has to pay his own fine.
